

INSTRUCTIONS TO ALL SERVICE PLATEAU USERS

In accordance with the Rulebook on the order of the special purpose port - nautical tourism port-marina "Kremik," the General Terms and Conditions of Marina Kremik d.o.o. and the General Terms and Conditions of Kremik Nautic Center d.o.o., all users of Kremik Nautic Center d.o.o. services (hereinafter: "Marina Service"), all subcontractors and all persons present in the service plateau area are obliged to comply with the aforementioned general acts (hereinafter "General Acts").

By entering the service plateau area, a natural or legal person (entity) confirms that they have read, understood, and accepted the General Acts.

In accordance with the General Acts, Owners and/or Vessel Users who use the services of dry berth and service plateau are hereby informed that when lifting the vessels and carrying out work on maintenance and repair of their vessels, must comply with the following rules:

- I. Only crew members may work on the vessel, whereby crew members are considered persons registered on the crew list.
- II. If the planned intervention on the vessel includes the type and scope of works that cannot be performed by the vessel's crew, the Owner/Vessel User shall contact the Marina Service office for all further consultations and drawing up a work plan, and shall use the available services of the Marina Service.
- III. In the marina "Kremik", it is not allowed to hire third parties, i.e., external repairmen, for the maintenance or servicing of vessels without the prior consent of the Management.
- IV. If it is determined during the consultation between the Marina Service and the Owner/Vessel User that the Marina Service cannot perform the works, the marina "Kremik" will, at the request of the Owner/Vessel User, grant consent for the use of the services of external specialized repairers.
- V. Every entry of external specialized repairers must be registered at the marina "Kremik" reception.
- VI. The fee for the entry and work of external specialized repairmen is defined by the marina "Kremik" price list.
- VII. External specialized repairmen can perform work on the vessel every working day from 08:00 to 16:00. Extension of work hours is possible only with the approval of the marina "Kremik".
- VIII. When performing work on the vessel, it is mandatory to use a vacuum cleaner during sanding and/or sawing on the vessel.
- IX. Waste oil, oil, grease, detergents, batteries, and all other hazardous waste must be disposed of by the Owner/Vessel User, the vessel's crew and/or an external specialized repairer in designated waste disposal containers.
- X. After finishing the work on the vessel, the plateau and the surrounding work surface must be cleaned. If the Owner/ Vessel User does not clean the plateau and the surrounding work surface no later than 10:00 the day following the day on which the work was

completed, the cleaning will be carried out by the marina "Kremik", and the Owner/Vessel User will be charged for cleaning by the price list.

- XI. The crane's work is carried out in an operating area clearly marked with signs. The Owner/Vessel User, the vessel's crew, and any other persons not employees of the Marina Service are not authorized to access the crane operating area under any circumstances.
- XII. The crane is managed and handled exclusively by authorized employees of the Marina Service. Unauthorized persons are not allowed to operate the crane, nor can the crane be rented for personal use.
- XIII. Before starting the vessel lifting operation, the Owner/Vessel User shall inform the crane operator verbally or via email of the equipment on the underwater part of the vessel and shall provide accurate information about its position, as well as all other relevant information that could affect the successful lifting of the vessel. In the event that the Owner/Vessel User fails to provide the crane operator with the above-mentioned information, the Marina Service shall not be liable for any damage caused to the equipment on the underwater part of the vessel during the lifting process.
- XIV. The Marina Service area is not a pedestrian zone. The movement of persons around the Marina Service area is at their own risk. Parents are responsible for their children. Underage children must be supervised by their parents.
- XV. The Owner/Vessel User is responsible for all persons staying or coming to the vessel while in the Marina Service.
- XVI. Movement on the vessel's surface while on land is at your own risk.
- XVII. It is prohibited to keep and park vehicles in the Marina Service area. The maximum permitted vehicle speed is 10 km/h. Driving a vehicle in the Marina Service area is at your own risk.
- XVIII. Entry for loading and unloading or delivery vehicles are allowed. The Marina Service shall not be liable for any damage caused to the vehicles while they are in the Marina Service area.
- XIX. The Owner/Vessel User shall be liable to the Marina Service and the marina "Kremik" for any and all damage caused to them due to non-compliance and/or actions contrary to the General Acts and these Instructions.
